## **Purpose and legal basis for the processing of data**

Purpose: Traceability of infections with COVID-19

The legal basis for the processing of data is art. 6 sect. 1 number d DSGVO (processing of personal data for the protection of essential interests of the person concerned or any other natural person). This also applies to the processing of personal data in order to monitor epidemics and the spread of diseases.

Another legal basis for the processing of data is art. 6 sect. 1 number c DSGVO in conjunction with § 13 sect. 4 sent. 3 of the Fourth Bavarian Regulation on infection protection measures as well as number 3.2.3 and number 3.2.9 of the hygiene concept gastronomy (*common publication of the Bavarian State Ministry for Health and Care as well as for Economics, Regional Development and Energy as of 14 May 2020, reference number 6a-G8000-2020/122-315; published in the Bavarian Ministerial Gazette 2020 number 270 as of 14 May 2020*). These regulations stipulate the collection and processing of data from owners of a gastronomic business.

## **Recipient of the data collected**

The data collected may only be forwarded on request of the responsible health authorities in order to trace possible paths of infection.

## **Storage period**

The contact data will be stored **for the duration of one month** and then be deleted.

## **Your rights as regards the processing of your data**

As a person concerned, you have the right of access and verification of your personal data collected; upon expiry of the storage period, you have the right of deletion of your data in view of the Sibyllenbad. In this case, please contact us under above mentioned address. Independent of the expiry of aforementioned storage period, the Sibyllenbad is moreover obliged to delete your data upon expiry of said period.
